GENERAL TERMS AND CONDITIONS FOR EVENTS

§ 1 Definitions and Validity of Conditions

The following general terms and conditions regulate the contractual relationship between the participant (hereinafter "service recipient") in training courses, seminars etc. (hereinafter "event") and Flexco Europe GmbH based in 72348 Rosenfeld (hereinafter "service provider"). They therefore also apply to all future business relationships, even if they are not expressly agreed again. General terms and conditions of the participant are not valid. Deviations from these terms and conditions are only effective if they are confirmed in writing by the service provider.

§ 2 Offer and Registration

The service recipient receives the "event offer" (event overview, brochures, internet, or newsletter announcement) for the event he / she wishes. This offer is non-binding. Registration for an event can be made via the internet, letter, fax, or e-mail and becomes legally binding with the written confirmation of the service provider.

§ 3 Service and participation fees

The participation fee listed in the price list is per person and event date plus the applicable statutory value added tax. Unless expressly agreed otherwise in the offer, the range of services includes participation in the respective event date, event documents, lunch, and refreshments during breaks. Accommodation, travel, and other costs are not included in the participation fee, unless otherwise agreed. The scope of the service results primarily from the event description. The service provider reserves the right to make changes, e.g. changing the venue, replacing announced speakers with others, and making necessary changes to the event program while preserving the overall character of the event.

§ 4 Training documents, copyrights

Event documents and electronic data carriers made available by the service provider are included in the agreed participation fee. All event documents are protected by copyright. Participants are only granted a simple, non-transferable right of use for personal use. In particular, participants and third parties are not permitted to change the content or editorial content of the event documents - even in extracts - or to use modified versions, to copy them for third parties, to make them publicly accessible or forward them, to post them on the Internet or in other networks for a fee or free of charge, to imitate, resell, or use them for commercial purposes. Any copyright notices, marks, or trademarks may not be removed.

A recording of the event, e.g. on audio or video tapes, and / or digital storage by the participant is not permitted.

§ 5 Terms of payment

Unless expressly agreed otherwise in the offer, the participation fee is due for payment immediately upon receipt of the invoice without any deductions. The service recipient has to pay the contractually agreed participation fee in full, even if he misses the event, for whatever reason. If the participant is in default of payment, the service provider is entitled to charge default interest in the amount of 5% above the base rate (§247 (1), § 288 (1) BGB) p.a. If the service provider proves higher damage caused by default, this can be claimed. In the same way, the participant is entitled to provide evidence that the damage did not occur at all or was significantly lower than claimed by the service provider. The service recipient is only entitled to offset if the counterclaim is undisputed or has been legally established.

GENERAL TERMS AND CONDITIONS FOR EVENTS

§ 6 Withdrawal, cancellation, revocation

If the service provider is unable to hold the event due to force majeure or for an important reason (e.g. due to illness of the speaker or insufficient number of participants), the participants will be informed immediately. In this case, paid participation fees will be refunded. No further claims can be made against the service provider.

In the event of cancellation - only possible in writing - by the service recipient, a administration fee will be charged to the service recipient. A confirmed registration can be withdrawn free of charge up to 4 weeks before the start of the event. By withdrawal up to 2 weeks before the start of the event, the administration fee is 50% of the participation fee. In the event of a later withdrawal (≤ 2 weeks until the start of the event) or if the service recipient does not appear, 100% of the participation fee will be charged. It is possible to send a substitute participant.

Participants whose registration can neither be attributed to their commercial nor their independent professional activity (§ 13 BGB) have the right to revoke their registration in writing within 14 days of receipt of the confirmation of registration without giving a reason. There are no cancellation fees. To meet the deadline, it is sufficient to send the revocation in good time to the following address:

§ 7 Liability

The service provider assumes no liability for a success intended with the event and / or any intended admission to examinations and / or the passing of such examinations of any kind. The service provider and its vicarious agents are only liable for damage suffered by the service recipient in the event rooms (conference venue, etc.) in the event of willful intent or gross negligence.

This does not affect the liability of the organizer for damage resulting from injury to life, limb or health, as well as for claims under the Product Liability Act. In the case of slight negligence, liability is limited to direct damage resulting from the breach of an essential contractual obligation (obligation, the fulfillment of which enables the proper execution of the contract in the first place and compliance with which the contractual partner regularly relies and may rely, hereinafter referred to as "cardinal obligation"). In the event of a breach of a cardinal obligation, the organizer's liability is limited to compensation for the foreseeable, typically occurring damage; otherwise, liability for slight negligence is excluded. The limitation of liability also does not apply if the organizer has assumed a guarantee or has fraudulently concealed circumstances giving rise to damages.

The service provider is not liable for items brought in by the service recipient (cloakroom, event material, valuables, etc.). The respective house rules must be observed.

§ 8 Data collection and data protection

The storage and use of the personal data provided during registration is for the purpose of fulfilling the contract. Your data will not be passed on to third parties. For the duration of the contractual relationship, the service provider may save and use the personal data of the service recipient in compliance with the applicable data protection regulations.

Even after the contractual relationship has been completed, the service recipient agrees to receive information material from the service provider. The service recipient agrees that the service provider may use the data received during registration for marketing purposes in such a way that the participant is provided with brochures, programs and seminar information from the organizer. The participant can object to the use and processing of his data for marketing purposes at any time by notifying the service provider.

§ 9 Governing law, place of jurisdiction and place of performance

The law of the Federal Republic of Germany applies exclusively to the exclusion of the UN sales law.

The courts responsible for 72358 Rosenfeld are exclusively responsible for all disputes if the participant is a merchant within the meaning of the HGB or if the participant does not have a general place of jurisdiction in Germany.
